Terms and Conditions



The CAA 60th Anniversary Gala Dinner 'Gala' is organised and run by the Council of Ambulance Authorities. By registering for any part of the gala you agree to the terms and conditions set out below.

Registration and payment

To purchase tickets for Gala, attendees must register online and follow any directions set out. Payment is due in full at the time of purchase and your registration will not be confirmed until payment is received and may be subject to cancellation.

Please contact the Council of Ambulance Authorities on events@caa.net.au if you do not receive a confirmation email.

If a person is registering on behalf of an attendee/s it is the responsibility of that person to notify the attendee of the terms and conditions of registering, for which they will be agreeing to on the behalf of the attendee. Responsibility also includes providing full details of the attendee/'s registration details as confirmed.

Payment in full must be received at time of registration/purchase. In the event the full payment is not received before the deadline indicated, the attendee may be refused entry to the event and the registration/purchase will be considered as a cancellation.

Payment can be made by credit card, Visa, MasterCard and may incur credit card surcharges.

Cancellation and Substitution Policy

You may substitute a delegate at any time, without penalty.

Notice of cancellation and request for a refund, by individuals or groups, must be received in writing by email to Council of Ambulance Authorities, events@caa.net.au

The following cancellation charges apply for Gala:

- 60 days prior to Gala: Full refund
- Between 30 and 59 days prior to Gala: 50% refund
- Within 29 days prior to Gala: No refund (application for refund will be considered under exceptional circumstances)

No refund will be granted for failure to attend/no show.

The date of the email receipt will be the bases for considering refunds. Refunds will be made after the event less an administration fee of \$10.00 per person.

In the unlikely event of the Gala Dinner being cancelled by the organiser, a full refund will be made. Liability will be limited to the amount of the fee paid by the attendee and there will not be any additional liability to the Council of Ambulance Authorities, or any other individual associated with the event organisation.

In the event Gala cannot be held or is postponed due to events beyond the control of the event organisers (force majeure) or due to events which are not attributable to wrongful intent or gross negligence of the event organisers, liability will be limited to the amount of the fee paid by the attendee and there will not be any additional liability to the Council of Ambulance Authorities, or any other individual associated with the event organisation. Under these circumstances, the event organisers reserve the right to refund the fees paid minus an administration fee of \$10 per person.

Photography and Filming

Each attendee acknowledges and agrees that:

- (a) they may be photographed, videotaped or otherwise recorded by CAA in connection with Gala to produce photographic images, film recordings, sound recordings and other material incorporating an attendee's appearance, likeness, voice, quotations, comments and name;
- (b) CAA may use, reproduce, publish, broadcast, distribute, commercialise, adapt, modify, edit, sell, exhibit, store, dispose of, deal with or otherwise exploit in any media such comments or images (or any part of the Images) (Materials) for the purpose of CAA's future promotional and marketing purposes throughout the world (including without limitation, on the internet, such as CAA's website) without further reference or compensation to them;
- (c) they consent to the images being taken by or on behalf of CAA and understands that the patron may be identifiable in the materials; and
- (d) they waive all rights (if any) to inspect or approve the materials or their use by CAA in exercising the rights granted under this paragraph or control the use or disclosure of the Materials.

Insurance

Registration fees and/or purchase of ticket do not include insurance. All attendees are advised to procure their own insurance to cover all risks including (but not limited to) costs of travel, accommodation, ticket pricing, personal property, health and medical expenses, injury, death and all other risks. The event, host organisation and organisers will not be held liable for any claims under any circumstances.

Liability

In the event of industrial disruption or other unforeseen circumstances, the Host, Organising Committee and the Council of Ambulance Authorities accept no responsibility for loss of monies incurred by delay or cancellation.

Views expressed by speakers, sponsors and/or exhibitors are their own. The Council of Ambulance Authorities cannot accept liability for any advice given, or views expressed, by any speaker, sponsor and/or exhibitor at the Gala or in any material provided to delegates. In addition, the Council of Ambulance Authorities shall not be responsible or liable for any direct or indirect loss of damage of any sort incurred as the result of the services or information provided in connection with the event.

Privacy

During the process of purchasing a ticket/s, the Council of Ambulance Authorities will gather and record personal information necessary for your attendance. All personal information is gathered, stored and disseminated in accordance with the National Privacy Principles.

General

The Council of Ambulance Authorities reserves the right to change, amend, add or remove any of the above terms without prior notice. If one or more of the conditions outlined in these Terms & Conditions should be or become invalid, the remaining conditions will continue to be valid and apply. These Terms and Conditions apply to all participants of the Gala including attendees, speakers, sponsors and exhibitors.
